TÜRKİYE ENACTS CLIMATE LAW: A NEW ERA BEGINS FOR THE 2053 NET-ZERO TARGET

Türkiye has taken a critical step in the fight against climate change by enacting the Climate Law No. 7552, published in the Official Gazette on July 9, 2025.



This comprehensive regulation provides a legal framework for the country's 2053 Net Zero Emissions target, and mandates profound transformations across multiple sectors—including environment, energy, industry, and finance.

One of the key provisions of the law is the establishment of an Emissions Trading System (ETS). Under this system, companies operating in the energy and industrial sectors will be required to obtain permits and regularly report their greenhouse gas emissions.

The law also introduces the Türkiye Green Taxonomy, designed to encourage sustainable investment by classifying economic activities based on their environmental sustainability.

This will support the growth of green finance and help align Türkiye with international best practices.

In addition, the law paves the way for Türkiye's integration into the global carbon pricing system through the adoption of a Carbon Border Adjustment Mechanism (CBAM) aligned with the European Union. This mechanism will regulate the trade of carbonintensive products and reduce carbon leakage.

The legislation also involves local governments, mandating the establishment of Climate Change Coordination Committees in each province under the leadership of governors. These committees are required to prepare Local Climate Action Plans no later than December 31, 2027.

Importantly, all revenues generated from the ETS and related sanctions will be allocated exclusively to climate action and green transformation projects. Dedicated budgets will also be created to support just transition mechanisms.

Experts emphasize that this law marks a turning point in Türkiye's climate policy, integrating economic, social, and environmental sustainability within a holistic approach. Its effective implementation is considered vital for fulfilling Türkiye's international climate commitments and ensuring the country's integration into the global green economy.

FOREST FIRES IN TÜRKİYE IN 2025: 80,000 HECTARES BURNED, 12 LIVES LOST

Starting on June 25, wildfires affected 47 provinces across Türkiye throughout the summer, leading to the evacuation of more than 50,000 people.

The fires caused severe damage to both natural ecosystems and local communitie

İzmir (Aliağa, Foça, Buca, Seferihisar, Menderes, Kemalpaşa, Çeşme, Ödemiş)	25 June– 7 July	The largest fires occurred in İzmir, with more than 26,000 hectares burned.
Antalya (Kumluca, Finike, Manavgat)	25 June – 26 July	Several major fires were brought under control quickly.
Muğla (Köyceğiz, Marmaris, Menteşe)	25 June – 3 July	Fires were extinguished through rapid interventions.
Bilecik (Osmaneli, Gölpazarı)	25 – 27 June	Fires broke out near NATO facilities.
Hatay (Belen, Arsuz, Yayladağı)	30 June	1,800 hectares were damaged.
Manisa (Saruhanlı, Seyitoba)	15 – 16 July	A 20-hour-long fire was brought under control.
Tekirdağ (Şarköy)	15 – 17 July	The fire spread to Gelibolu; 4 neighborhoods were evacuated.
Çanakkale (Ayvacık, Gelibolu)	16 – 18 July	Fires were contained, but risk remains high.
Eskişehir (Büyükyayla, Seyitgazi)	24 – 26 July	10 responders lost their lives as a surface fire turned into a crown fire.
Sakarya (Akyazı, Geyve)	24 – 26 July	A fire vortex occurred; 4 villages were evacuated.

Overall Situation:

- Wildfires reported in 47 provinces
- Over 80,000 hectares of land affected
- More than 50,000 people evacuated
- 12 fatalities and 46 injuries reported

These fires caused severe ecological damage, significantly reduced air quality, and disrupted the livelihoods of local communities. The agriculture and tourism sectors were particularly impacted in the affected regions.

Government agencies continue to enhance wildfire prevention and early response capabilities through technology, education, and infrastructure investments. In the long term, forest restoration and sustainable forest management remain top priorities.

GROWING INEQUALITIES IN SUSTAINABILITY ACROSS EUROPE

According to the 2025 Europe Sustainable Development Report, progress toward the Sustainable Development Goals (SDGs) has slowed, with rising social inequalities and setbacks in sustainability performance coming to the forefront.



The report evaluates the SDG performance of the European Union and neighboring countries, highlighting significant disparities and a general slowdown in progress. It notes that since 2020, the pace of advancement toward the SDGs has sharply declined—and in some countries, even regressed. Key challenges are particularly visible in areas such as income inequality, access to services, and poverty, while progress in environmental protection, sustainable agriculture, and climate action remains limited.

Finland, Denmark, and Sweden top the ranking in sustainable development performance.

Türkiye ranks 34th with a score of 59.1. The report emphasizes that the EU must adopt more inclusive policies to stay on track with the SDGs. It also draws attention to disparities revealed by the "Leave No One Behind" (LNOB) Index, stressing the urgency for policymakers to address inequality.

The report calls on the new EU leadership to demonstrate greater commitment and investment in SDG implementation and underlines the need for shared action and stronger multilateral cooperation to meet the 2030 targets.
